Public Information Committee Report for WUIG 5/4/06

The committee met on 5/2/06. Present: Carol B, John B, Bobbye H, Tom S, Roberta Z.

1) **Community Fairs:**

On Sat April 8, we participated in the **New Rochelle YMCA's Healthy Kids Day**. While attendance was low, there was a request from the director of the children's camp for an OA speaker this summer to address the children. We will follow-up.

On Sat June 10, we will participate in the 26th Annual Ossining Community Fair, where OA volunteers will distribute meeting lists and free OA information. The space cost \$65. (Carol will coordinate event.)

2) **OA Public Service Tape (PSA):**

Currently the PSA is being aired on three local cable TV stations: White Plains, Mamaroneck and Rye. We are working with Cablevision, with a likely date of June 1, for airing on several major cable stations. More details to follow. (John continues to coordinate effort.)

3) **Flyers with our OA hotline, website and other contact information:**

Although several flyers have been posted in local supermarkets, community boards and businesses, we currently have no way to follow-up on the posting. Therefore, the committee decided to institute a method of tracking. The committee members will ask at meetings for OA volunteers to post flyers in their communities and provide their email address for subsequent follow-up (by Tom). We know that at least two people learned about OA by seeing a posted flyer. (Geographical areas: John (White Plains, Hartsdale); Bobbye (Ossining, Tarrytown, Croton); Tom (Mt. Kisco); Roberta (Larchmont, New Rochelle, Mamaroneck, Rye); Carol (Hastings, Ardsley, Irvington).

4) **Health Care Professionals:**

The committee has decided to focus on reaching health care professionals by soliciting names and addresses of physicians, social workers, psychologists, nutritionists and other health care professionals from the OA fellowship. A mailing list will be compiled and each health care professional will receive a meeting list and information about OA. A flyer is being developed which will describe this outreach endeavor. (Tom and Roberta will work on this project.)
